# **Trigger Warnings**

"You have power over your mind - not outside events. Realize this, and you will find strength."

# What is a trigger warning?

A trigger warning is an early notification of any subject matter which might be considered traumatizing for the audience. It has been particularly common in university lectures and reading lists, and is either issued verbally prior to lectures or presentations, or is part of the syllabus.

Trigger warnings have been enormously controversial. According to some estimates, around 51% of academics use trigger warnings. Some universities have begun to require that faculty use trigger warnings before they present potentially sensitive material. However, study after study has

In some cases, trigger warnings have been used to shield students from merely controversial ideas. And such warnings have been placed on many widely-read books and plays including *Things Fall Apart* by Chinua Achebe,

found them to be ineffectual.<sup>4</sup> Trigger warnings do not seem to help, but rather increase students' anxieties. They also lead to what many psychologists have warned, to a culture of "safetyism" and coddling of the mind.<sup>5</sup>

F. Scott Fitzgerald's *The Great Gatsby ,Mrs Dalloway* by Virginia Woolf, *Huckleberry Finn* by Mark Twain, and Shakepeare's *The Merchant of Venice.* <sup>7</sup> Even some of Grimm's Fairy tales—including Snow White, Sleeping Beauty, Hansel and Gretel, and Little Red Riding Hood<sup>8</sup>—have been subject to trigger warnings.

Trigger warnings have contributed a culture of safetyism and a significant weakening of resolve, fortitude, and stoicism<sup>9</sup> among today's students. Universities' willingness to apply trigger warnings has emboldened activists to go farther—demanding course and curriculum changes as well as deplatforming of speakers and "canceling" works of literature (such as Ovid's Metamorphoses .)<sup>10</sup>

In sum, "Trigger Warning" policies, though well meaning, have failed in study after study, have proven to be largely ineffective and in some cases harmful, and come with a host of negative externalities, such as:

- Posing a significant threat to academic freedom and challenging the rights of professors by compelling speech or restricting 'offensive or triggering' speech;
- Making unacceptable assumptions about the reader and relying on generalizations that these policies hope to avoid;
- Preventing dialogue in the classroom and denying students the opportunity to engage and debate important but difficult topics;

- Institutionalizing ineffective policies that do little more than censor the classroom in hopes of "protecting students from words on a screen"; and
- Contributing to a culture of safetyism and coddling on campus.

# Recommendations

The Martin Center recommends that universities take steps to limit the use of trigger warnings.

#### **Universities should:**

- Strongly discourage the use of trigger warnings but allow instructors to choose whether to include them on their syllabi or in courses.
- Make all syllabi public, preferably months ahead of the course or module.<sup>11</sup> Allow individual students to decide on their own whether they can handle a specific content.
- O Never require instructors to use trigger warnings.
- Adopt a statement in support of free expression (e.g. The Chicago Principles).
- O Defend instructors who teach controversial topics.
